


Hiilijalanjäljestä viestiminen


- Tuloksissa esitetään Suomen kansallisoopperan ja -baletin potentiaaliset kasvihuonekaasupäästöt vuonna 2019
 - Tulokset eivät ole absoluuttisia arvoja ja epävarmuudet liittyen tuloksiin tulee huomioida tuloksia tulkittaessa
- Hiilijalanjälki on laskettu perustuen dataan joka on saatu selvityksen tilaajalta eli Suomen kansallisoopperalta ja -balettilta
 - Suomen kansallisooppera ja -baletti on vastuussa datan tarkkuudesta
- Hiilijalanjälki on laskettu GHG-protokollan standardien mukaan (*Corporate standard and Corporate value chain (Scope 3) standard*)
 - Kaikki relevantit kategoriat Scope 3 osalta on sisällytetty laskentaan ja valinta perustui Suomen kansallisoopperan ja –baletin toiminnan kokonaisuuksiin.
- Hiilijalanjälkilaskentaa ja sen raporttia ei ole verifioitu kolmannen osapuolen toimesta
- Hiilijalanjälkilaskennan tuloksista voidaan viestiä kolmannella taholle (muulle kuin laskennan Tilaaja organisaatiolle) kun tulosten esittämisen yhteydessä esitetään tämän dian sisältö.









Some Emission Factors

- Planed pine batten **0,09 kg CO₂e/kg**
 - Aluminium **7,2 kg CO₂e/kg**
 - 2 mm PVC Dance Marley **39 kg CO₂e/kg**

- Printed polyester fabric **1,18 kg CO₂e/m²**
 - Theatrical Muslin (cotton) **14,5 kg CO₂e/m²**
(about the same weight per m²)

Why Calculate Carbon Footprint?

This will help management and the environmental head to:

- Directing resources to effective actions
- Identifying the need for emission offsetting
- Monitoring the effectiveness of actions with a possible new calculation in the future

- We have started to make **a roadmap for net zero**



The Roadmap's Sequence of Actions

1. Emission avoidance measures


- An emission avoidance measure is a measure that is not taken.
- If implemented, they may also reduce costs, i.e. they bring savings when the activity is not carried out.

2. Emission reduction measures

- Measures that aim to reduce emissions from an activity.
- Often require financial resources, i.e. an investment.

3. Offset payments
